

Schedule of Fees



In an effort to help clarify our fee schedule; below is a detailed explanation of our installment payment procedures.

The school calendar year consists of 180 days that the children are in attendance. Each month varies from another in the amount of days attended. Due to the variance, we have broken up the extended day fees into 10 equal installments, each equaling 18 days of care.

Florida state law requires that all services must be paid in full prior to services being rendered.

Due to state law and regulation payments are due on the 15th of the month. All payments past due by 5 days will be rendered a \$5.00 late fee. If balance is unpaid by the date in the "Covers Your Childs Care Through:" box below, your child will be unable to attend Extended Day until balance is paid in full.
