The following are some very important procedures and requests that we would like to share with you:

- Camp Extreme is open to all current K-5th graders (2024-2025 school year).
- Non-Refundable Registration fee is \$100 per week, per child.
- Each 4-day Extreme Camp week, Monday- Thursday, is \$175.00 per child.
- Please register, and pay registration fee, for each week you plan for your child to attend. Registration and fee will reserve their space for your chosen camp week. Each week has 40 extreme spaces available.
- Camp fees, \$175 per week, per child, must be paid one full week in advance before your chosen week of camp begins.
- Please bring ID when picking up and make sure your authorized pick-up persons are listed so we may release your child safely and appropriately.
- Kiddos may be signed in as early as 8:00am and must be picked up by 4:30pm at the very latest. This is strictly enforced by SJCSD.
- Please be sure your child has a change of clothes (if you feel it is needed),
 water bottle and a full lunch in hand when checked in. A mid-morning and
 afternoon snack will be provided.
- Sneakers Please. We will be running and playing ALL day!
 - * Please no sandal's, Crocs, or flip-flops

Julington Creek Elementary Summer Enrichment Camp Expectations Policy

Parent's Expectations of the Program:

- 1. Their children are cared for in a safe supportive environment.

- 5. Julington Creek Elementary Summer Camp will provide for the children a variety of developmentally appropriate activities, including crafts, active play, games, and social skills building.

Program Expectations of the Parent:

- 1. Keep your child's records complete and up to date.
- 2. Pick up your children on time.
- 3. Pay attention to any communication from the director regarding your child's behavior and cooperate in efforts to bring about improvement in the situation.
- 4. Provide communication between yourself and Julington Creek Elementary Summer Camp staff regarding a change in your child's home experience so we can work as partners in meeting the needs of your child.


Student Behavior Expectations:

Students will...

- Be kind to others
- Always stay within sight of the group leader
- Share equipment and take turns properly
- Use appropriate language- no cussing, no name calling, no racial slurs
- Be courteous when others are talking
- Use inside voices while inside
- Follow safety guidelines and rules while on school property
- Clean up after yourself and help your group leader and others clean up as well
- Respect others and their property
- No physical violence (hitting, punching, kicking, biting, tripping, spitting) toward another person
- No bullying
- Do not pick up rocks or sticks while on school property
- No chewing gum on school property
- Cell phones must always remain in back packs
- Electronic games that do not have internet access are allowed when teacher gives permission at appropriate times

Discipline and Consequences

Parents will be notified when their child is unable to meet our student behavior expectations. A pattern of continuous behavior issues may lead to a temporary suspension or a removal from the Julington Creek Elementary Summer Camp. An offense of physical nature, such as biting, punching, kicking, pulling hair or spitting will immediately lead to a temporary suspension and any further offenses thereafter will lead to permanent removal from the Julington Creek Elementary Summer Camp. Any student who uses physical force with a group leader will immediately and permanently be suspended from the program as well. *Refunds Due to Suspension from Program- All tuitions paid prior to your student's temporary or permanent suspension will be forfeited.
